COURSE OUTLINE

The mission of Healthcare Training Centers of America is to empower and prepare Nursing Assistant and Home Health Aide students to provide high-quality and compassionate care for residents in all healthcare settings.

NURSING ASSISTANT/HOME HEALTH AIDE TRAINING PROGRAM

This program aims to prepare students to sit for the examination to become certified nursing assistants and prepare them to become Home Health Aide. The school will educate the students based upon the federal and state recommended curriculum. This will prepare the students to sit for the examination and teach them practical skills that they can use in their chosen field.

The Faculty of Healthcare Training Centers of America, Inc. is made up of highly qualified registered and professional nurses with a wide range of experience in the health care industry, with a particular focus on long-term care and community nursing environment.

The program is taught in two distinct parts. The first part of the program will be classroom lectures and laboratory training. This session is designed to expose the students to the theory behind the practice of clinical training. The second session of the program is the clinical rotation. This section will be conducted in a long-term care facility. The students will have the opportunity to practice what they have been taught in the classroom and the laboratory. They will interact with the patients and apply "hands-on" what they have learned.

Tuition and Fees

This is a 115-hour course that meets Monday through Friday between 8:00am to 3:00pm for day class and 3:30pm to 10:30pm for the evening class. This is a 4-week program. Tuition for this program is \$950.00, and the student is responsible for his or her own books, uniforms, and other supplies. Students must be up to date with his/her tuition before or by the first day of class.

HOME HEALTH AIDE TRAINING PROGRAM

Home Health Aide are health care professionals who provide care to the client in the comfort of their own homes. Their duty varies from routine housekeeping to providing personal care and activities of daily living to the individual. Home Health Aides also work in places other than individual private homes. They work in Adult daycare centers, Assisted living facilities, Homecare Agencies, and Self-employment. The need for Home Health Aide and Homemakers services and their chances of employment cannot be over-emphasized due to the increased number of elderly, hospital discharge, and hospice services.

Tuition and Fees

This is a 80-hour course that meets Monday through Friday between 8:00am to 3:00pm for day class and 3:30pm to 10:30pm for the evening class. This is a 3-week program. Tuition for this program is \$750.00, and the student is responsible for his or her own books, uniforms, and other supplies. Students must be up to date with his/her tuition before or by the first day of class.

WHAT QUALIFICATIONS DO I NEED TO BE ADMITTED INTO THE NURSE AIDE TRAINING PROGRAM?

Able to read and write English at the 7th-grade level. A High School Diploma or equivalent is NOT required for admission to the program. CPR Certification & Proof of negative TB test by a healthcare facility is required for admission to the Nursing Assistant program. Students must meet the physical requirement and have documentation to perform the tasks of a nurse assistant and/or home health aide, including having no lifting restrictions. Candidates must take a written assessment test for entrance to the program. The written assessment test includes basic math (such as addition and subtraction) and general English proficiency skills.



Upon receiving a passing grade on this test, students are eligible to enroll in the Nursing Assistant/ Home Health Aide Training course. The assessment test is free of charge. Hours of testing vary and are either on a drop-in basis or scheduled by appointment. Students may be required to submit a background check as a precondition of participating in a clinical/internship component of the training. Students need to be aware that that past criminal records may prohibit them from participating in clinical/internship components of training and/or gaining employment within the medical field.
